Arizona Convention Kills
Proposal To Sell Hospital

PHOENIX, Ariz. (BP)--After nearly five hours of debate, messengers to a special session of the Arizona Southern Baptist Convention here voted 422-208 to keep two of its hospitals rather than sell them to a hospital chain.

The convention turned down an offer from American Medicorp., Inc., to buy the Phoenix and Scottsdale Baptist Hospitals for \$8 million in cash plus assuming outstanding liabilities of the two hospitals. Total purchase price would have been \$12.6 million.

American Medicorp., a Philadelphia-based hospital holding company, had recently purchased Doctor's Hospital of Phoenix and its officials said they wanted to add the two Phoenix-area Baptist hospitals to their complex.

The convention's Executive Board had recommended that in the light of the offer, the special convention be held to consider the sale of the hospitals, but it did not recommend whether the offer should be accepted or rejected.

During the convention, a motion was made that the convention re-affirm its 1968 convention action to continue its hospital ministry, and not to sell the hospitals.

A substitute motion which in effect accomplished the same thing was offered by James Staples, former editor of the Baptist Beacon in Phoenix and now public relations director for the Scottsdale Hospital.

Staples' motion stated that "...In order that we may keep our fellowship, and have faith in our God and ourselves, I recommend that we keep our institutions and agencies and instruct the Executive Board to study and recommend to the November, 1969 convention, ways and means of a closer relationship between our institutions and agencies, even to the sharing of available monies in a legitimate and ethical manner..."

The motion also asked for a study of the Arizona Baptist Hospital Association in an effort to align the association more closely with the convention.

In the end, the convention voted 422-208 in favor of Staples' motion, settling the question and turning down the offer to buy.

American Medicorp representative Dr. Allen Ginn commended the convention "for your democracy, and for your sincere interest in your fine hospitals.

"They are among the very best hospitals or we would not have wanted them in the first place," Dr. Ginn continued. "I only wish that every hospital had a group of people like you behind them."

Convention Executive Secretary Charles L. McKay declared after the vote: "This is our finest hour." He said the vote "reassures ourselves that we are in the business of giving the total gospel to the total man.

"To my knowledge," McKay added, "no individual or group of individuals has led any crusade or campaign whatsoever to sell either of our hospitals. The offer came, and the officers of the Arizona Southern Baptist Convention felt that the people ought to decide...."

"They have spoken," McKay said. "At least two thirds of those who voted went on record as being completely dedicated to hospital ministries as a part of our mission endeavor to get the gospel to all men everywhere.

"After much deliberation, the fact remains that the convention believes in this ministry and we shall commit ourselves to becoming one of the great medical complexes needed in Arizona," said McKay. "We must not settle for mediocrity."

Attendance at the special called session, held at First Southern Baptist Church of Glendale, topped 1200, with 920 registered messengers from at least 150 churches, Convention officials said it was the largest attendance in its history.

Chafin Urges Evangelicals:
Enlarge Outreach Target

MINNEAPOLIS (BP)--A Southern Baptist speaking to the U. S. Congress on Evangelism here called on evangelical churches to enlarge their target of evangelism.

Kenneth Chafin, professor of evangelism at Southern Baptist Theological Seminary in Louisville, cited two areas in which this enlargement needed to take place--with young people and adults not reared in the church, and with classes of people other than the majority of the membership.

"Let's face it, most of our evangelism is baptizing the children of the families of our churches," Chafin said.

"The church that is nothing but a sociological extension of the family will never need the power of the resurrection. We already have all the power we need for the tasks we are attempting. We need to undertake larger tasks," he said.

Chafin asked that churches move out of their hot houses and into the fields of the world to share with all people the gospel.

Chafin was the most prominent Southern Baptist, other than Billy Graham, on the program of the congress. He was pinchhitting for the SBC President W. A. Criswell. Criswell was unable to attend because of minor surgery.

During its third day, the congress took an unexpected turn of linking conservative evangelicalism with the Negro struggle for equality. Black leaders in a press conference expressed surprise that the congress so quickly came to grips with what they called the real issues of our society.

One black Lutheran, Nelson Trout, said, "Many of us came with tongue-in-cheek, but we have sensed a rebirth of the church, addressing itself to the world. The congress has showed an awareness that the world set the agenda."

Tom Skinner, a fiery young black evangelist from New York who brought the congress to its feet with a standing ovation, said "This is the most historic church congress ever to meet in our country, and if we leave here without our heads screwed on, we can make an impact on this country."

Skinner challenged white Christians to be ready to die for the cause of racial equality. "The black revolution obliges true believers to express their love toward each other even if it means ultimate sacrifice."

He said that the current revolution is one with identity, community and power. He compared the present age with the time in which Jesus' disciples lived, when there was a confrontation of Jewish nationalist-radicals with a Roman establishment. The disciples he declared pointed to a better way even though it meant alienation from both elements.

He emphasized the need for the conservative evangelical to open up Bible schools, seminaries, colleges, businesses, and churches to the black Christian.

"Because the conservative schools were closed to the black Christian, they went to the more theologically liberal schools and consequently most of the black leadership has a liberal orientation," he exclaimed.

When the question of Communist influence in the black community was raised during a press conference, Trout said, "I don't want to dignify Communism by giving them the credit. People ask 'who stirred them up?' as though black people do not have enough sense to know that someone has their foot on their neck."

He said it was simply an easy out--to blame the Communist.

"The church must take a stand against racism," Skinner said. "It must do so on the grounds as such principles are based on the Kingdom of God. It must be willing to loose its shirt for such a stand."

Skinner said the church had produced "relationships thicker than brother and sister. That fellowship in the Christian church supersedes every other type of relationship."

Black churchmen composed less than 2 per cent of the delegates attending the congress. Their short representation was blamed on two factors: the expense of the congress and the conflict of dates with meeting with large Negro Baptist conventions.

Georgia Board Avoids Federal
Aid, Approves Hospital Loan

ATLANTA (BP)--The Georgia Baptist Convention Executive Committee, plagued in recent years by persistent debate over federal funds for Baptist schools, went through one of its busiest sessions in years without a ripple of debate or controversy.

Federal aid was not discussed, but is expected to draw major attention when Mercer University reports to the convention in November on its February application for federal construction grants an application which followed three recent convention votes against the use of federal funds for Georgia Baptist institutions. The convention meets in Atlanta Nov. 10-12.

At the Executive Committee meeting, Georgia Baptist Hospital in Atlanta reported that a major expansion which it has been planning for several years will cost almost \$12 million, instead of \$9 million as anticipated a year ago.

The Executive Committee gave approval for the hospital to secure a \$6 million commercial loan for the new building. The hospital commission has raised \$3 million in gifts and pledges.

In another action, the committee approved a 1970 Georgia Baptist Convention Cooperative Program budget of \$5,648,000, an increase of \$303,200 over the 1969 budget. Biggest single increase was a \$50,000 hike for state mission funds in Georgia.

The Georgia Executive Committee also gave preliminary approval to a statement of purpose for Georgia Baptists in Christian higher education. Its Education Commission has been studying such a statement for almost two years.

The statement is a broad, general one which reaffirms the validity of "institutions of higher learning with a Christian philosophy, perspective and commitment."

An Executive Committee resolution urged the Georgia delegation in the U. S. Congress to work for tax law revisions "which maintain essential incentives to giving in support of religious, educational and benevolent causes."

That resolution specifically mentioned "gifts of appreciated property without payment of tax on capital gains" and other charitable gifts and trusts.

The Georgia convention leaders also urged the pastoral care program of Georgia Baptist Hospital to "consider the possibility of expanding its program to include a counseling ministry to pastors."

The committee voted to sponsor publishing of a book on the history of the Georgia Baptist Convention, to be published in 1972, when the convention will be 150 years old.

James A. Lester, editor of the Tennessee Baptist and Reflector and former public relations secretary for Georgia Baptists, was asked to write the new history.

Georgia Baptists were also asked to make cash offerings to help Baptist churches, individuals and institutions in Mississippi, Louisiana and Alabama to repair damages caused by Hurricane Camille.

Two retirements and one resignation were announced to the committee. Retiring as of Dec. 31, will be Arthur Hinson, Annuity Board representative and assistant executive secretary, and Mrs. Martha R. Settle, music field worker. Garnie A. Brand resigned as Training Union secretary to become development director for Norman College (Baptist), Norman Park, Ga.

Texas Board Recommends
Federal Loans For Agencies

DALLAS (BP)--The Executive Board of the Baptist General Convention of Texas voted here to recommend that its institutions, including schools and hospitals, be allowed to seek long-term, low-interest rate government loans.

The recommendation, which will come up for consideration at the annual convention when it meets in San Antonio in November, is identical to a recommendation which the convention defeated by a vote of 739 to 536 during its 1966 annual session.

Included in the recommendation is a clause stating that the institutions should voluntarily reimburse the government annually for the amount of interest to cover the government subsidy involved in the loan.

In other action, the 192-member board voted to recommend a \$14½ million budget for 1970 to the convention, and approved a report from a Cooperative Program study committee which would alter the budget format and planning, if approved at the convention.

The board also authorized up to \$5,000 for possible use in filing an "amicus curiae" (friend of court) brief to the Supreme Court which would present a Texas Baptist viewpoint on taxation of church and denominational property.

The board approved a request by Baptist Memorial Hospital in San Antonio to lease two satellite hospitals, with an option to buy the facilities.

Actual text of the recommendation on federal loans reads as follows:

"We recommend that the Baptist General Convention of Texas approve the securing of long-term, low-interest loans from public funds for construction of buildings by Texas Baptist institutions, provided the institution voluntarily reimburses the government annually the additional amount of interest which will cover the government subsidy involved in the loan.

"This amount will be determined by the Treasury Department estimate of cost based on the average rate produced by the going market yield on issues with remaining terms to maturity of 15 years or more at the time the loan is secured plus one-fourth of one per cent per annum for administrative costs. The amount of the subsidy each year will be recommended to the institutions on this basis by the Program Coordinating Committee of the Executive Board."

Enlarged Evangelism Concept
Proposed To End Polarization

MINNEAPOLIS (BP)--A Presbyterian minister from Washington, D.C., suggested an enlarged concept of evangelism during the U. S. Congress on Evangelism here to "help dissolve the destructive polarization between evangelism and social responsibility."

Richard C. Halverson, noted author and pastor of Fourth Presbyterian Church in Washington, asked the 5,000 delegates, including 500 Southern Baptists, to lay aside conventional views for the purpose of rediscovering what the New Testament says about evangelism.

"Evangelism is treated," he said, "not as a task to be done, a department of church life, and not even as the primary role of the church. Rather, evangelism is something that is happening all the time when the church is truly community, truly in fellowship, truly renewed and renewing."

He asked why some Christians isolate and emphasize evangelism as being more important than the two great commandments which comprehend all the law and the prophets, "to love God and neighbor."

He further asked how some Christians could separate the Great Commission with its mandate, "teaching them to observe all things whatsoever I have commanded you."

He criticized pastors who "are on the backs of people," exhorting them to witness and scolding them for failing "instead of feeding them so they will be healthy--rightly related to Christ and the community."

The deepest need of most Christians, he said, is for the nourishment which the whole council of God provides in authentic fellowship.

Episcopal layman Keith Miller, characteristically frank, told the congress that "we evangelicals are the most frustrated of all people with our problems of the inward journey."

He indicated that the problem is worse for the committed Christian because he has been taught that if he is restless or lonely, it may be a reflection on the depth of his commitment.

"When we committed Christians get vulnerable enough to open our lives in a natural way, people see the living Christ at work, healing and changing miserable lives before their eyes. Sometimes they find hope," he said.

Miller, noted for his frank sharing of his own pilgrimage in his books, said, "Real fellowship cannot be programmed in the church basement with Koolaid. I believe the answer will have to have built into it a restless unfulfillment, as a serum must have within it something of the disease."

The church has identified too closely with the answer, and not enough with the problem, Miller suggested. "Those who become vulnerable enough to the problems to identify with them will be those who are able to share their faith with the world."

Southern Baptist Theological Seminary Professor Kenneth L. Chafin of Louisville, during a press conference, explained the generation gap within the churches by characterizing young people as being idealistic concerning social issues and relativistic on personal morality, while adults are just the opposite.

Chafin said young people need (1) secure and mature leadership from adults "who don't come apart when confronted with today's problems," (2) an interest in the structures of the church, since the only thing many have been given to do is to rebel, (3) acceptance as persons though not necessarily approval, and (4) a word from the church that adults know the context in which young people are living.

The Baptist professor also observed that American Protestantism has been hypocritical in its attitude toward the poor, reacting more to governmental programs than to the needs of the people or to Biblical teachings.

"We feel we can excuse our lack of compassion for the poor by criticising and rejecting governmental programs," Chafin said. "I know of churches with hundred thousand dollar budgets that spend less than \$300 for the poor in their community."

The recommendation, which will come up for consideration at the annual convention when it meets in San Antonio in November, is identical to a recommendation which the convention defeated by a vote of 739 to 536 during its 1966 annual session.

Included in the recommendation is a clause stating that the institutions should voluntarily reimburse the government annually for the amount of interest to cover the government subsidy involved in the loan.

In other action, the 192-member board voted to recommend a \$14½ million budget for 1970 to the convention, and approved a report from a Cooperative Program study committee which would alter the budget format and planning, if approved at the convention.

The board also authorized up to \$5,000 for possible use in filing an "amicus curiae" (friend of court) brief to the Supreme Court which would present a Texas Baptist viewpoint on taxation of church and denominational property.

The board approved a request by Baptist Memorial Hospital in San Antonio to lease two satellite hospitals, with an option to buy the facilities.

Actual text of the recommendation on federal loans reads as follows:

"We recommend that the Baptist General Convention of Texas approve the securing of long-term, low-interest loans from public funds for construction of buildings by Texas Baptist institutions, provided the institution voluntarily reimburses the government annually the additional amount of interest which will cover the government subsidy involved in the loan.

"This amount will be determined by the Treasury Department estimate of cost based on the average rate produced by the going market yield on issues with remaining terms to maturity of 15 years or more at the time the loan is secured plus one-fourth of one per cent per annum for administrative costs. The amount of the subsidy each year will be recommended to the institutions on this basis by the Program Coordinating Committee of the Executive Board."

Enlarged Evangelism Concept
Proposed To End Polarization

MINNEAPOLIS (BP)--A Presbyterian minister from Washington, D.C., suggested an enlarged concept of evangelism during the U. S. Congress on Evangelism here to "help dissolve the destructive polarization between evangelism and social responsibility."

Richard C. Halverson, noted author and pastor of Fourth Presbyterian Church in Washington, asked the 5,000 delegates, including 500 Southern Baptists, to lay aside conventional views for the purpose of rediscovering what the New Testament says about evangelism.

"Evangelism is treated," he said, "not as a task to be done, a department of church life, and not even as the primary role of the church. Rather, evangelism is something that is happening all the time when the church is truly community, truly in fellowship, truly renewed and renewing."

He asked why some Christians isolate and emphasize evangelism as being more important than the two great commandments which comprehend all the law and the prophets, "to love God and neighbor."

He further asked how some Christians could separate the Great Commission with its mandate, "teaching them to observe all things whatsoever I have commanded you."

He criticized pastors who "are on the backs of people," exhorting them to witness and scolding them for failing "instead of feeding them so they will be healthy--rightly related to Christ and the community."

The deepest need of most Christians, he said, is for the nourishment which the whole council of God provides in authentic fellowship.

Episcopal layman Keith Miller, characteristically frank, told the congress that "we evangelicals are the most frustrated of all people with our problems of the inward journey."

He indicated that the problem is worse for the committed Christian because he has been taught that if he is restless or lonely, it may be a reflection on the depth of his commitment.

"When we committed Christians get vulnerable enough to open our lives in a natural way, people see the living Christ at work, healing and changing miserable lives before their eyes. Sometimes they find hope," he said.

Miller, noted for his frank sharing of his own pilgrimage in his books, said, "Real fellowship cannot be programmed in the church basement with Koolaid. I believe the answer will have to have built into it a restless unfulfillment, as a serum must have within it something of the disease."

The church has identified too closely with the answer, and not enough with the problem, Miller suggested. "Those who become vulnerable enough to the problems to identify with them will be those who are able to share their faith with the world."

Southern Baptist Theological Seminary Professor Kenneth L. Chafin of Louisville, during a press conference, explained the generation gap within the church by characterizing young people as being idealistic concerning social issues and relativistic on personal morality, while adults are just the opposite.

Chafin said young people need (1) secure and mature leadership from adults "who don't come apart when confronted with today's problems," (2) an interest in the structures of the church, since the only thing many have been given to do is to rebel, (3) acceptance as persons though not necessarily approval, and (4) a word from the church that adults know the context in which young people are living.

The Baptist professor also observed that American Protestantism has been hypocritical in its attitude toward the poor, reacting more to governmental programs than to the needs of the people or to Biblical teachings.

"We feel we can excuse our lack of compassion for the poor by criticising and rejecting governmental programs," Chafin said. "I know of churches with hundred thousand dollar budgets that spend less than \$300 for the poor in their community."
