DR. E. D. HEAD RESIGNS SOUTHWESTERN SEMINARY

FORT WORTH, Tex.--(BP)--Dr. E. D. Head has resigned as president of Southwestern Baptist Theological Seminary, effective August 1, of this year. He submitted the resignation to the board of trustees in session here for the spring meeting, stating that ill health was the reason and that by resigning he hoped to regain his strength. He suffered a heart attack last year soon after a preaching mission to Japan.

Dr. Head became president of Southwestern Seminary in 1942, succeeding the late Dr. L. R. Scarborough. Before that he was pastor of the First Baptist Church, Houston, Tex., 1932-1942 and associate professor of Bible in Baylor University, 1920-1932.

The record of Southwestern Seminary under Dr. Head's leadership has been marked with great gains in every phase of its life. Enrolment increased from 636 in 1942 to 2,160 for the current academic year, a gain of 240 per cent. Property value increased from \$1,732,080 in 1942 to \$4,177,000 for last year. The biggest single project is the great multi-purpose Memorial Building, built at a cost of two million dollars and dedicated in 1950. Receipts for the operation of the seminary increased from \$160,434 in 1942 to \$574,799 for 1951.

A committee has been appointed by the board to find a successor for Dr. Head.

NASHVILLE, Tenn. -- (BP) -- For the second year Texas Baptists have raised more than a million dollars for foreign missions through their Lottie Moon Christmas offering.

Receipts from the offering, sponsored annually by the Woman's Missionary Union, this year reached \$1,250,105.98.

Total gifts to the Lottie Moon Christmas offering from all the states had reached \$3,107,160.66 the second week in March.

BUILDS \$1,100,000 EDUCATIONAL PLANT

TULSA, Okla.--(BP)--The First Baptist Church here recently dedicated a \$1,100,000 improvement to their educational properties including a new six floor building and renovation of the old educational building. The new plant provides for thirty-seven departments. The roof is equipped as an outdoor recreation area with tile flooring, stage with dressing rooms and barbecue pit. An air-conditioned office suite includes reception center, pastor's study, administrative offices and separate offices for the secretarial staff. Dr. J. W. Storer, prominent Southern Baptist leader, is pastor.

Registration Cards for Southern Baptist Convention by Joe W. Burton, Secretary

Registration cards for messengers who will attend the Southern Baptist Convention in Houston, May 6-10, are available from the office of the Baptist state secretary in your state.

It will greatly facilitate the enrolment of messengers in Houston if each messenger will bring his card to Houston properly prepared.

Pastors who have not received registration cards may secure them by writing directly to the Baptist state secretary.

The maximum number which any church may designate as messengers to the Convention is ten, provided by the Convention by-laws. There is no provision for alternates.

The constitutional provision concerning messengers is as follows: "Membership: The Convention shall consist of messengers who are members of missionary Baptist churches co-operating with the Convention as follows:

- 1. One messenger for each regular Baptist church which is in friendly co-operation with this Convention and sympathetic with its purposes and work and has during the fiscal year preceding been a bona fide contributor to the Convention's work.
- 2. One additional messenger from each such church for every 250 members; or for each \$250 paid to the work of the Convention during the fiscal year preceding the annual meeting.
- 3. The messengers shall be appointed and certified by the churches to the Convention, but no church may appoint more than ten (10)." --Baptist Press

RECOMMENDS SEMINARIES
CHANGE FINANCIAL YEAR

NASHVILLE, Tenn.--(BP)--The Executive Committee of the Southern Baptist Convention

NASHVILLE, Tenn.--(BP)--The Executive Committee of the Southern Baptist Convention is recommending that the Convention meeting in Houston, May 6-10, change the fiscal year for the seminaries so that it will be for the twelve month period ending July 31. It is now for the twelve month period ending Dec. 31. The change is in order to make the fiscal year of the seminaries in agreement with the school year. No other Southern Baptist Convention agency or institution will be affected. The recommendation action means that the By-laws of the Convention will have to be amended in two places and the Business and Financial Plan in three places.

HOSPITAL COMMISSION SEEKS CHARTER CHANGES

NEW ORLEANS, La.--(BP)--The Southern Baptist Hospital Commission is seeking approval of the Southern Baptist Convention that meets in Houston, Tex., May 6-10, for permission to change two articles of its charter. These changes are necessary because of the relationship of the Commission to the new hospital authorized by the Convention for Jackson-ville, Fla., last year.

Article VII will provide for a board consisting of not less than fifteen nor more than forty members. Nine of them will live in or near the city of New Orleans and nine will live in or near the city of Jacksonville, Fla. Article IX will provide for an executive committee for the Commission consisting of not less than five and not more than nine members. Three of these members shall live in or near the city of New Orleans and shall be members of the administrative committee of the New Orleans hospital, three shall live in or near Jacksonville and shall be members of the Jacksonville hospital and the remaining three will be from Alabama, Georgia, or Mississippi.

APPROVAL FOR CHANGE IN CONSTITUTION REQUESTED

At the meeting held January 27, 1953, the Board of Directors unanimously voted to request the Convention's approval of the following changes in the hospital's charter:

Article VII to be amended to read as follows:

The affairs of this corporation shall be controlled and managed by a board consisting of not less than fifteen nor more than forty members of this corporation, nine of whom shall live in or near the city of New Orleans, La., and nine of whom shall live in or near the city of Jacksonville, Fla., which said board is hereby designated as the Board of Directors of this corporation. They shall be elected annually by the Southern Baptist Convention at the elections to be had at the annual meeting of the said Southern Baptist Convention. Vacancies occuring in the membership of the board during the interim between annual sessions of the Southern Baptist Convention may be filled by the remaining members of the board, who for that purpose but no other, may nominate and elect additional members of this corporation; such members thus elected to serve until the next succeeding meeting of the Southern Baptist Convention. Should the Southern Baptist Convention fail for any reason to elect such members of said board at their annual meetings, then the members of the board then in office shall continue in office until their successors are duly elected, qualified and installed.

2...Hospital Commission

Article IX to be amended to read as follows:

The Board of Directors shall meet the last Thursday in January and shall elect from among their number a president, a vice president, and a recording secretary. These officers shall hold office during the term of the Board of Directors or until their successors are elected, qualified and installed. The Board of Directors is authorized also to elect an executive committee to consist of not less than five nor more than nine members of said board. Three members of the executive committee shall live in or near the city of New Orleans and shall be members of the administrative committee of the Southern Baptist Hospital. Three members of the said committee shall live in or near the city of Jacksonville and shall be members of the administrative committee of the Baptist Memorial Hospital of Jacksonville, Fla. The remaining three members of the Board of Directors from Alabama, Georgia and Mississippi. The executive committee shall be vested with the authority to control and manage the affairs of the corporation in the interim between the meetings of the Board and may be vested with such other power as the Board may deem proper to confer upon them. Service of legal process may be made upon the president of the corporation; or in his absence upon the vice president, or in the absence of both upon the secretary.
